TERMS OF CONTRACT

PAYMENT

A 20% down payment must be made within 10 days of booking your trip. If there is no down payment received, you will be notified that your booking has been cancelled. The balance of 80% is due in full 40 calendar days before your trip.

PROGRAM/CHANGES

We are committed to providing you with everything we state in the detailed itineraries of our programs. Nevertheless, we reserve the right to make changes in the program as required due to circumstances beyond our control.

If the length of time between your booking and your trip is longer than three months and if prices for hotels, airfares, boat rentals or gas rise in unforeseeable ways, we reserve the right to a maximum of a 10% increase in price. If any changes occur that exceed 10% you have the right to cancel this contract.

CANCELLATION

By the participant:

If you choose to cancel your trip, we can only provide you with a refund if we have somebody on the waiting list who can replace you or if you put someone else in your place. Our groups are so small that one or two cancellations can endanger the whole expedition.

This is why we strongly advise you to cover yourself properly with travel insurance.

By the operator:

In the unlikely case of not reaching a minimum number of 10 participants, we reserve the right to cancel our program until 14 calendar days prior to the trip. In that case your payment will be fully refunded.

CANCELLATION during the program

If you violate the laws or the culture of the countries we are visiting or if you badly disrespect captain's orders or safety rules on board our boats or in the water, e.g. if you get drunk on board during our dolphin and shark encounters, if you take or sell illegal drugs, if you break the rules of international dolphin encounter e.g. if you feed the dolphins, hurt or harass them or if you kill a shark or display cruelty towards humans or animals, we reserve the right to exclude you from the program without further notice.

LIABILITIES

Claudia Hahm, the program operator, is liable for

- careful planning of the expedition
- careful choice and monitoring of the chosen partners and sub-operators
- the correctness of the program description
- the execution of the program

EXCLUSION OF LIABILITY

Participation in all program events is completely at your own risk. Please understand that Claudia Hahm or any of her partners or sub-operators cannot be held liable for any damages.

We strongly advise you to cover yourself properly with travel insurance.

PRIORITIES

Our first and utmost priority is the safety of our travelers. The decision whether the weather conditions are good enough to take the boat out on the water is completely in the captain's hand.

In case of changes in the program due to bad weather, i.e. conditions beyond our control, no refunds are possible.

ENTRY-REQUIREMENTS / CUSTOMS-FOREIGN EXCHANGE-HEALTH- REGULATIONS

It is your responsibility to meet the rules and regulations for entry of the USA and the Commonwealth of the Bahamas.

PLEASE NOTE: For entry into the USA, Europeans need a valid modern passport with a digital photo. Your entry must be announced online via ESTA prior to your trip. Swiss citizens must apply for a visa. Find out what conditions apply for you NOW! It is not nice to be sent home at the airport!!!

US Citizens: Please remember you also need a passport for entry into the Commonwealth of the Bahamas!
